

## HISTORY OF DIRECTOR COMPENSATION

Directors at 25 public authorities received compensation until 1992. Governor Cuomo signed Chapter 55 L. 1992 and ended that practice.

The pay structures were as such (with current day values in parentheses):

**\$100 a day (\$138.70) “when rendering services”, not to exceed \$5,000 a year (\$6,935)**

**\$50 a day (\$69.35) “when rendering services”, not to exceed \$2,500 a year (\$3,467)**

- Environmental Facilities Corporation
- Housing Finance Agency (*Chair receives a salary of \$25,000 (\$34,467) if he/she only serves as chair and is not an employee of HFA.*)

**\$150 a day (\$208) “when rendering services”, not to exceed \$15,000 a year (\$20,800)**

- Capital District Transportation Authority
- Central New York Regional Transportation Authority
- Niagara Frontier Regional Transportation Authority
- Rochester Genesee Regional Transportation Authority
- MTA

**\$100 a day (\$138.70) “when rendering services”, not to exceed \$10,000 a year (\$13,870)**

- New York Convention Center Operating Corp.

**\$150 a day (\$208) “when rendering services”, not to exceed \$10,000 a year (\$13,870)**

- Fort Erie Bridge Authority

**Other compensation packages**

- Central New York Regional Market Authority -- \$15 (\$20.81) a meeting, not to exceed six meetings in one year. Members of the executive committee receive \$15 for every executive committee meeting not to exceed 8 in one year.
- Genesee Valley Regional Market Authority --\$25 (\$34.68) a meeting, not to exceed six meetings in one year. Members of the executive committee receive \$25 for every executive committee meeting not to exceed 8 in one year.
- Power Authority -- Each trustee shall receive \$12,500 (\$17,337) a year. Salary for chair set by trustees (same today).
- Albany Port Commission – Chair receives \$5,000 a year, other members receive \$3,000.
- Roosevelt Island Operating Corporation -- \$150 a day.
- Thruway Authority – Chairman’s salary is \$25,000 (\$34,675), other board members \$17,000 (\$23,579.)
- Hudson River Black River Regulating District – Per Diem set by Environmental Conservation Commissioner.
