

Review of Public Complaint

Nassau County Bridge Authority

June 12, 2023

PC-2023-01

The Complaint

The Authorities Budget Office (ABO) is authorized by Section 6 (2) (d) of Title 2 of Public Authorities Law to investigate and act on complaints concerning the failure of a public authority to comply with State law.

On November 15, 2022, the ABO received a complaint from the public stating that the Nassau County Bridge Authority (Authority) is violating Open Meetings Law (OML) by not posting meeting dates, agendas, or minutes to its website. The complaint also alleges that the Authority does not have an email address for the public to send Freedom of Information Law (FOIL) requests.

Scope of the Review

This report is a limited scope review of the transparency of the Authority's website between January 4, 2023 and January 10, 2023. Based on the complaint, we reviewed the website to identify if the Authority is posting meeting dates, agendas, and minutes as required by OML. In addition, we determined if the Authority's website includes an email address for the online submission of FOIL requests. We also determined if the Authority was posting other reports and information required by Public Authorities Law. Our review focused on current information and required data for the fiscal year ending December 31, 2021. The focus of our review was limited to verifying that the required information is posted on the Authority's website and did not address the substance of these documents. This report is limited to the information and documents available on the Authority's website during the period reviewed.

Background

The Authority was established in 1945 by Title 7 of Public Authorities Law to operate and maintain the Atlantic Beach Bridge, which spans the Reynolds Channel between the Village of Lawrence and Atlantic Beach in Nassau County. The Authority is defined under Section 2 of Public Authorities Law as a local authority.

The Authority is governed by a five-member Board of Commissioners, all of whom are appointed by the Nassau County Executive with the approval of the County Legislature. The Authority's fiscal year begins on January 1.

Results of Investigation of Complaint

Complaint: Is the Nassau County Bridge Authority (Authority) violating Open Meetings Law by not posting meeting dates, meeting agendas, and meeting minutes to their website as required? Does the Authority have an email address to send Freedom of Information Law requests posted to its website?

The complaint was measured against Public Officers Law requirements. In addition, the Authorities Budget Office (ABO) has issued Recommended Practice: Board Meetings: Best Practices Guide for Public Authorities and Policy Guidance No. 22-01: Posting and Maintaining Reports on Public Authority Websites, together to be referred to as ABO Guidance, to assist authorities in the transparency of their meetings and websites.

Section 104 of Public Officers Law, more commonly known as Open Meetings Law (OML), requires a public body to provide public notice of the time and place of a meeting scheduled at least one week in advance, to the news media and conspicuously posted in one or more designated public locations, at least 72 hours before such meeting. In the case of meetings scheduled less than one week in advance, such notice is required to the extent practicable at a reasonable time prior to the meeting. In each case, such notice should be conspicuously posted on the public body's website in advance of a board meeting. ABO Guidance requires local authorities to post a schedule of all board meetings at the beginning of the fiscal year and board meeting agendas are to be posted one week prior to the meeting. Our review found that the Authority did not post a schedule of meetings for the year on its website. On January 9, 2023, we found the Authority's website included a notice for its January 11, 2023 board meeting, but the agenda for the meeting was not included on the website.

Section 106 (3) of OML requires meeting minutes to be posted to a local authority's website within two weeks from the date of the meeting. Our review found the Authority is not posting all board or committee meeting minutes on its website. We were only able to find board meeting minutes for 2022 and nothing for 2021 and 2023 was posted. We found no committee meeting minutes posted on the website.

Section 89 of Public Officers Law, more commonly known as Freedom of Information Law (FOIL), requires a public body to accept requests for records through electronic mail (e-mail) and ensure that its website provides for online submission for FOIL requests. Our review found the Authority is not posting any information on its website pertaining to how to submit a FOIL request or an email address for the public to send FOIL requests. However, while not conspicuously posted, we were able to locate the main contact information address, phone, and a link to a general email address for the Authority.

Conclusion: The Authority is not posting meeting notices, schedules, agendas, and meeting minutes as required by Open Meetings Law and ABO Website Guidance. In addition, the Authority is not posting an email address for the public to send FOIL requests.

Other Observations: Pursuant to Section 2800 of Public Authorities Law (PAL), state and local authorities are to make documents pertaining to their mission, current activities, annual financial reports, budgets, and independent audit reports accessible to the public on the authority's official or shared website. To assist state and local authorities meet their disclosure and reporting obligations, the ABO Website Guidance provides a checklist of policies, reports, and other information that the Authority should maintain online in accordance with the Public Authorities Reform Act of 2009 and other provisions of law.

We found the Authority has not made certain information available on its website as required by Section 2800 of PAL. For example, we found the Authority is not posting its enabling statute, organization chart, or information on its executive management, board members and committees. In addition, we found the Authority is not posting a four-year budget plan or reports on procurements and investments. The full results of the website review are attached.

Recommended Action of the Board

Recommendation Based on Complaint: The Nassau County Bridge Authority (Authority) board should ensure its board meeting schedule, notices, agendas, and meeting minutes for the Board and its committees are posted to the Authority's website in accordance with Open Meetings Law. In addition, the Authority should provide an email address for the public to send FOIL requests, in accordance with the Freedom of Information Law.

Other Observation Recommendation: We have concluded the Authority needs to make additional required information available on its website. Please review the attached website review results and take appropriate action so that all information required under Section 2800 of Public Authorities Law is available online and easily accessible to the public. Further, please provide the Authorities Budget Office with a written confirmation that you have fully addressed these concerns by July 24, 2023.
